

Chinese New Year Greeting Newsletter including Global China Academy Annual Report (2021–2022)

Dear colleagues and friends,

As the Year of the Rabbit 2023 hops gently forward, it is our pleasure to take this opportunity to give you an update on our situation and activities. We hope that you will continue to lend us your valued support and interest and to participate in our various events.

The GCA Board of Trustees have submitted GCA's final Trustees Annual Return (TAR, from 1st April 2021 to 31st March 2022) of the existing charity (registration number: 1154640) to the Charity Commission in December 2022. On the 17th May 2022 our application to become a Charitable Incorporated Organisation (CIO) registered with the Charity Commission was approved (registration number: 1198983). This means that the first financial year of the CIO will be from 17th May 2022 to 31st March 2023 (deadline for submitting TAR is 31st January 2024). Thereafter the reporting periods will coincide with the UK financial year, i.e. 1st April to 31st March every year.

PART I. SOME POINTS FROM THE TAR

The objects of the charity are:

- to encourage the study of China in global and comparative perspectives in all its aspects, and to contribute to the building and governance of a global society;
- to bring theories and methods from studies of Chinese society and comparative studies of China from different social scientific disciplines into the realm of human knowledge;
- to use academic resources from China, the Chinese and global and comparative studies to provide a knowledge-based social consultancy and build a public dialogue platform;
- to publish peer-reviewed journals and books, to create and manage bilingual websites and events;
- to act as a bridge between China and the rest of world, the Chinese and the non-Chinese, through knowledge transfer, consultancy and public engagement with both global public goods and global public good for serving global society.

The trustees have had regard to the guidance issued by the Charity Commission on public benefit.

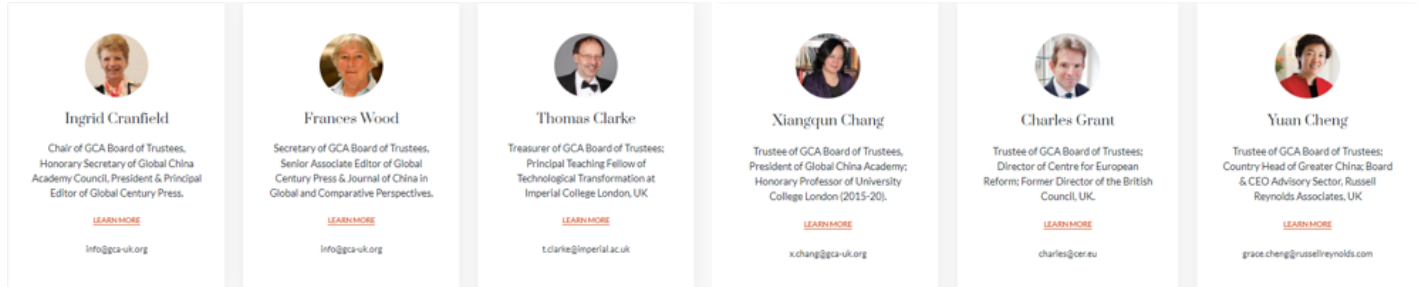
During the year, the COVID-19 pandemic affected China in different ways and different kinds of pandemic restrictions worldwide slowed down the [Global China Academy](https://www.gca-uk.org/) (GCA)'s work in its four main areas:

- Developing individual and institutional fellowships and maintaining a unique global network with a mailing list of more than 6,000 like-minded people in the China in Comparative Perspectives Network Global (CCPN Global); encouraging links through its comprehensive and high-quality bilingual website, which is under reconstruction.
- Encouraging the study of China in global and comparative perspectives.
- Our peer-reviewed journals such as [Journal of China in Global and Comparative Perspectives](https://www.gca-uk.org/journal-of-china-in-global-and-comparative-perspectives/) (JCGCP) produce high-quality academic and intellectual products; encourage interdisciplinary, inter-institutional, transnational and comparative approaches; and facilitate collaborative studies on China in its Asian and global contexts.
- Developing [Global Century Press](https://www.gca-uk.org/global-century-press/) (GCP), the first publisher in the world dedicated to bilingual publishing of academic, practical and popular books on China in global and comparative contexts. The results of research and any consequent policy outcomes are fed back into and reflected in our publications to serve the global academic community and the good of society worldwide.
- Holding a series Global China Dialogues (GCDs), of which there have been seven to date, based on the concepts of transculturality and social creativity, to enhance public understanding of global affairs and participate in global governance.

The main achievements:

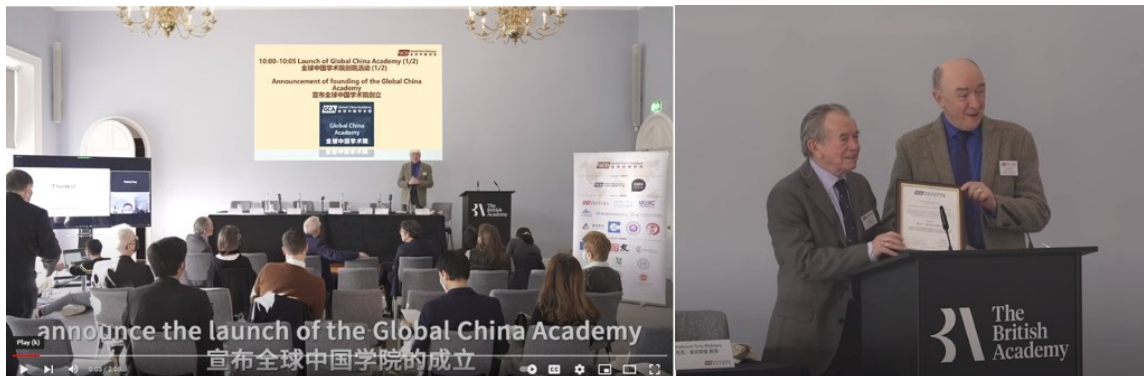
During 2021-2022, the Global China Institute (GCI) became the Global China Academy (GCA). We define GCA as a UK-based independent worldwide fellowship that encourages comprehensive studies on China in the social sciences and humanities. Taking language-based comparative and global perspectives, it aims to add to the sum of human knowledge. It also encourages participation in building and governance of a global society.

GCA's governance structure consists of [a Board of Trustees](#), who have legal responsibilities to run the organization in accordance with charity law and are responsible for monitoring risks and for taking the lead in implementing appropriate action to reduce risk.



[The GCA Council](#) is composed of prominent individuals who have a clear interest in the study of China in a global context. The Council will play a key role in the Academy, as it will not only advise and guide the GCA as it moves towards its next phase of development and beyond, but will also be active in a range of ways, including the recruitment of new Fellows, contribution of articles to our journals, recommendation and submission of books for publication by GCP, recommendation of themes and speakers for GCDs and an active involvement in raising the GCA's profile.

[GCA was formally launched](#) during the 7th Global China Dialogue (GCD VII), on 10th December 2021 at the British Academy.

GCA's academic and social missions are fulfilled mainly through publications by Global Century Press (GCP) and the Global China Dialogue (GCD) forums, which were created for the dissemination of academic research, knowledge transfer, social consultancy and public engagement.

Based on GCP's unique English–Chinese dual-language publishing standards in the global publication industry and unified rules for our English–Chinese bilingual typesetting, all the GCP journals and books can be identified as ‘transcultural productions’. *Theory, Method and Practice in Media Discourse: A Corpus-based Study of Low Carbon in Chinese, UK and US Media*, by QIAN Yufang and YE Mengdi, published by GCP in 2020, won Second Prize in the 21st Zhejiang Philosophy and Social Science Outstanding Achievement awards.

At the GCD VII, [a new book was launched at the Closing session and Reception](#). It is entitled [China and the Shared Human Future: Exploring Common Values and Goals](#), by Martin Albrow, edited by Xiangqun Chang. This volume serves as a companion to Martin Albrow's previous book, [China's Role in the Shared Common Future: Towards Theory for Global Leadership](#) (2018). The new book aims to encourage the globalization of Chinese social sciences and their incorporation into the sum of human knowledge. It consists of essential selections of work on the theory and practice of globalization (Chapter 2) by the author, a British social theorist and pioneer of global studies, based on his 60-year academic career, which laid a solid theoretical foundation for this book. In the past 10 years, the author has paid much attention to the issue of global governance and China. The editor collected almost all the author's complete works in Chapters 3–6, including academic papers and writings, newspaper articles, lectures, speech notes in academic and public conferences, academic and media dialogues or interviews and remarks for China's special occasions during this period. Together, they showcase the author's bidirectional engagements with Chinese academia, politics, publishers and media on practical themes such as fighting COVID-19, the BRI and lifting the Chinese out of poverty. They offer an insight into how China participates in the shaping of a global society, enabling readers to grasp the author's thoughts and opinions in the context of China in a global setting. Based on the creative idea of the ‘globalization of Chinese social sciences’, the editor has brought together a large number of examples of the help given by the author over the past 40 years to Chinese scholars and professionals to fulfil their academic and social missions in China and the UK (Chapters 7–8).

Following the launch of the [Journal of China in Global and Comparative Perspectives](#) (JCGCP) at the GCD II at the British Academy in 2015, two further academic journals were formally launched. One was the [Journal of Corpus Approaches to Chinese Social Sciences](#) (JCACSS). In the era of big data, how to find new methods to analyse large electronic texts poses a challenge to the existing quantitative and qualitative analysis methods of social science. The complex social problems in the era of globalization have challenged sociolinguists. The Centre for Corpus Approaches to Social Sciences, established by Lancaster University with the financial support of the Economic and Social Sciences Research Council, has applied corpus methods to some social sciences, such as the environment, crime and health. Under the guidance of Professor Tony McEnery, Director of the Centre, and with the support of colleagues at home and abroad and of the Global China Institute, a workshop on corpus approaches to Chinese social sciences was successfully held in 2016. The present JCACSS was planned at the time, its purpose being to introduce the new corpus approaches to the field of social science in China, explore and publish relevant research and provide an academic exchange platform for people with common interests. [Speeches relating to the journal were made by its joint Executive Editors](#), the first delivered online by **Dr Qing Cao** (online), Associate Professor in the School of Modern Languages and Cultures, Durham University; and the second delivered in person by **Dr Gavin Brookes**, Research Fellow of the Department of Linguistics and English Language at Lancaster University.



The other journal launched at the above event was [Journal of Chinese for Social Science](#) (JCSS). It examines the use of the Chinese language in context and draws academic attention to the usefulness and validity of existing translated texts and language usage in Chinese social science. To achieve conceptual equivalence between English and Chinese poses a great challenge, particularly in social scientific research across these two languages, cultures and societies. It is often the case that the research is published in a language that is not the researcher's first language and requires translation. However, translation can bring a range of potential risks in crosscultural or transcultural communication if not done appropriately. A bilingual academic journal with corresponding annotations and commentaries has paved the way to minimizing these risks, and the spin-off JCSS takes crosscultural or transcultural research to an even higher level. It not only

highlights the issues in translating research findings but also engages in, stimulates and promotes ‘dialogue’ between languages, cultures and communities. More often than not, translations – frequently out of context – can reinforce an orientalised Chinese identity. JCSS seeks to remove the obstacles to effective dialogue and the exchange of ideas through the translation of terms and concepts in their context. ‘Chinese for social science’ or ‘Chinese language for Social Science’ is a branch of ‘Chinese for Specific Purposes’ (CSP), like ‘Chinese for science and technology’ or ‘business Chinese’. This innovative idea was first developed by the GCA.

The GCD is a series that began in 2014 with the aim of bringing together scholars and practitioners from China and the rest of the world to exchange their insights into the problems that challenge human existence on our planet today. The GCA has attracted wide participation in its GCD forums by speakers and delegates from many different organizations, including universities in the UK, USA, China and France, as well as public and governmental institutions, NGOs and media. Our aim is to yield proposals for the reform of global governance based on these insights. We consider global governance in the broadest sense to cover the worldwide ordering of society to enable the peoples of the world to meet existential challenges, and to give the chance for human beings everywhere to lead fulfilling lives. China’s ‘community of a shared future for mankind’ also provides the world with a similar vision. GCD have successfully held seven GCDs. They are GCD I: The Experience of China’s Modernization from a Comparative Perspective in 2014, GCD II: Transculturality and New Global Governance in 2015, GCD III: Sustainability and Global Governance for Climate Change in 2016, GCD IV: The Belt and Road (B&R) – Transcultural Cooperation for Shared Goals in 2017, GCD V: Governance for Global Justice in 2018, GCD VI: Governance for World Peace in 2019, GCD VII: Reforming Global Governance in 2021.

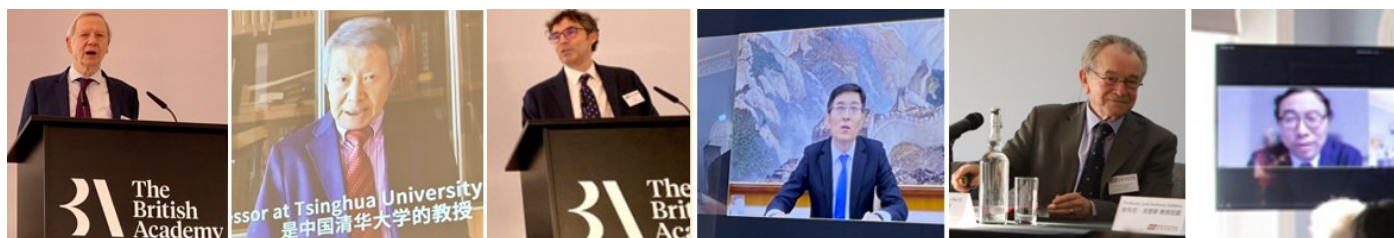

They were Transformations: Society and Environment; Digital Security and Geopolitics; Personal Identity, Cultural Identities, State and Corporation; and Reforming the Institutions.

The Opening session was chaired by Professor Tony McEnery.



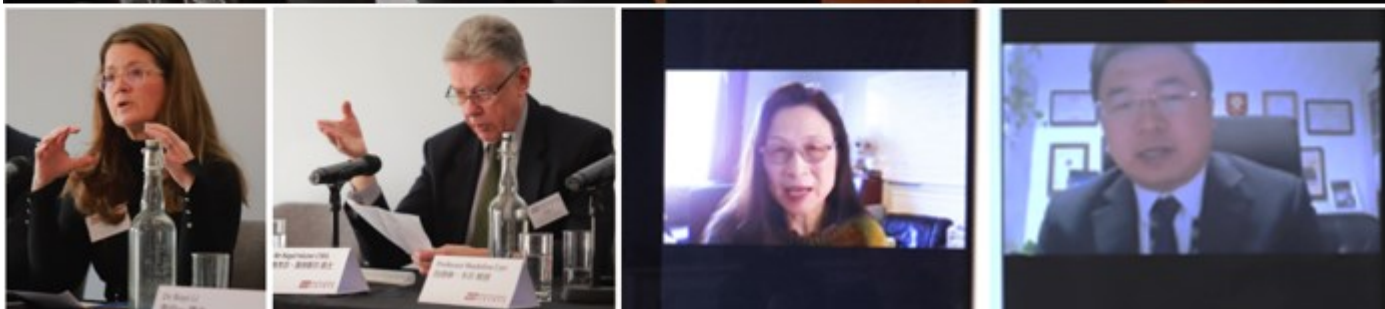

Financial review

Global China Academy is a UK-based independent worldwide fellowship that aims to develop, encourage and enhance the study of China in global and comparative perspectives through dissemination of academic research, knowledge transfer, social consultancy and public engagement, and to contribute to the building and governance of a global society.

Previously, our principal sources of funds have been participation fees for the Global China Dialogue series; from 2020, our principal sources of funds mainly came from GCP’s professional services for publications, supplemented by voluntary/philanthropic donations from friends and family as in previous years. It is hoped that sales of goods, such as books and journals, Fellowship fees and the provision of services will enable GCA to make a profit.

PART II. SOME ACTIVITIES IN CHINA AND WORKS IN PROGRESS

GCA activities in China

On her trip to China from early September to mid-November, Professor Xiangqun Chang participated in a series of meetings and activities with related parties there.

On the 17th September, a meeting was held in the Tsinghua Science and Technology Building at Tsinghua University, Beijing. It was organized by GCA Trustee Dr Yuan Cheng (front right), Country Manager of Greater China, Russell Reynolds Associates (UK), and Professor LAN Chun of Beijing Foreign Studies University, Executive Editor of the *Journal of Chinese for Social Science* (JCSS, front left). All the GCA Founding Fellows and Life Fellows participated in the meeting online and offline.

The renowned Chinese anthropologist and sociologist Fei Xiaotong conducted his fieldwork in the village in 1936, which resulted in his book *Peasant Life in China* (1938). Based on her thorough fieldwork in the same village, Professor Chang published *Guanxi or Li Shang Wanglai ? : Reciprocity, Social Support Networks, Social Creativity in a Chinese Village* (in English and Chinese, 2010 and 2011). She has been developing the concept of 'reciprocity' and testing it in and outside China. Based on the above fieldwork, on 15th October, Professor Chang delivered a speech entitled ‘Reciprocity (*Guanxi*) or reciprocity (*lishang-wanglai*): a case of building a community with a shared future for mankind in a Chinese village’, at the international conference ‘China and the World: Exploration and Innovation of Applied Journalism and Media Studies’, Tongji University, Shanghai.



On 16th–17th October, Professor Chang visited Suzhou City, the ‘Heaven City’ in China. She had an enjoyable visit to a Cantonese tea house, Chaoren Fang, which mixed different styles of Chinese calligraphy including ‘kung fu calligraphy’, a kind of performative art, accompanied by Dr HUI Haiming (right). The owner, Mr WANG Kai (2nd right), believed this is a good way to communicate with people from different cultural backgrounds. They also walked in underdeveloped original residential places in Ming Dynasty in Suzhou City. One wonders if Heaven City can get any better!



On 18th–21st October, Professor Chang visited Wuxi City, a historic city over 3,200 years old, with its Grand Canal. A UNESCO World Heritage site, it now has the highest per capita GDP in China. The visit was arranged by Mr DU Yichao (3rd right in green, **left photo**, with his colleagues), PhD candidate in anthropology at University College London. He is also Director of Wuxi New Culture Research Institute. **Centre**: Officials and experts from Liangxi District accompanied Professor Chang on visits to places of interest. **Right**: For COVID tests and to obtain different codes, Professor Chang’s UK passport was checked everywhere throughout her visit to China. This one was in Wuxi, which was designated a zero-risk city at that time.



The photo **left** was taken on 12th November 2022 in Shenyang City, while Professor Chang was queueing for a COVID test on a snowy day. It is truly remarkable how the COVID situation changed dramatically two weeks after she left China. ‘Understanding China and the World’, one of GCP’s book series, is clearly important and will remain so.

In Part II we have described the above activities to allow our global colleagues to meet some of our Chinese colleagues and contacts in China for the purposes of sharing information and networking.


